

Golf Cart Rental Agreement

The rented golf cart(s) is (are) for (name) _____. I agree to the following conditions. In the event that I violate any of the following conditions, I agree and understand that I will be charged for any damages and/or prohibited from future rentals from Indian River Golf Car Rentals.

- I promise to return the rented golf cart(s) to the location delivered or picked up, in as good condition as I received. I will operate the golf cart safely and responsibly, and I will preserve and protect the golf cart from loss or damage to the cart itself, my person or property, and the persons or property of others. I agree to be legally and financially liable for all costs of repairs to the golf cart, and for the loss, damage and/or injuries to my person or property and the persons or property of others regardless of fault.
- I understand there is a \$500.00 deposit (per cart rented) held on the credit card provided by the customer at the time of reservation for the said rentals. By providing a credit card number to Indian River Golf Car Rentals, I authorize them to hold the dollar amount of the required deposit until after the rental is completed. There is a \$10.00 charge for every lost key provided for the rented golf carts. If an electric cart is used for the rental period, there must be enough charge to drive/load the electric cart back onto Indian River Golf Car Rentals, delivery trailer. Failure to re-charge the batteries (on electric carts) will result in charges of a \$10 recharge fee.
- I agree to hold harmless, defend and indemnify Indian River Golf Car Rentals, and the owner of the golf cart for any and all damages and claims of any nature whatsoever that may arise from the use of the golf cart itself, my person and property and the persons and property of others.
- I agree to become familiar with the operation and use of said golf cart, and any other instructions provided to me regarding the cart, and to operate the golf cart in accordance with said instructions. I agree to contact Indian River Golf Car Rentals, if I have any questions or concerns about operating the golf cart or if my guest or I have caused any damage to the golf cart or others through the use of the golf cart. I agree to examine and inspect the safety and mechanical condition of the golf cart, reporting any concerns or problems before driving the vehicle.
- I understand that a golf cart is subject to the same laws and regulations pertaining to motor vehicles and therefore agree that the golf cart will be operated in accordance with the laws of the State, including but not limited to the requirement that persons driving the golf cart must not be under the influence of alcohol and/or illegal drugs. I further agree that I personally will be responsible for all moving and/or parking violations issued to said cart while it is in my possession, under my control, or at any time during the rental period.
- I agree that only persons who are 18 years or older and possess a valid driver's license shall be permitted to drive the golf cart. I further agree that the maximum occupancy of the golf cart is the number of available seats (no standing on the fender or in the back bag well).
- I understand the golf cart will be returned to Indian River Golf Car Rentals, with no tape, adhesive, decorations, balloons, streamers, etc. If the cart is not returned clean, there will be a \$50.00 cleaning charge per cart.
- I understand that if the golf cart should be inoperable through no fault of mine, I will contact, Indian River Golf Car Rentals, the day of this occurring, as Indian River Golf Car Rentals, will take reasonable steps to have the vehicle repaired as soon as it is possible to do so.
